Auction 30 results are posted

Results of the 30th auction of the Plate Number Coil Collectors Club have been posted both on the club Web site and in this issue of *Coil Line*.

Auctioneer Joe Sedivy reports that there were 68 bidders and all but four won at least one lot. There were 608 lots posted and 378 were sold. Those sold included 14 of 15 of the donated lots. All of the money from those lots goes directly into the club treasury. The club also collects a percentage of all other sales.

Lots sold from \$2 to \$550.

Joe reports there were few problems with the auction and he appreciates the cooperation and patience of all involved.

Call for Price Lists

... and Volunteers

The Catalog Committee plans publication of an updated PNC Values List this summer. The Values List has been our most popular product.

Dealers that want their price list to be included in the median prices we calculate should have their price list to me no later than July 1. Last year's values list had prices for PS5 and used singles plus a separate list for Backnumber pricing.

This year we plan to expand and do PS3, PS5, Used Singles, Commercial Covers, Backnumbers and Precancel Gaps. To accomplish this, volunteers are needed to enter data from the dealers' price lists into an Excel Spreadsheet. If you are willing to help, please contact me.

Volunteers will be given a Master Values Spreadsheet Template. The template has the PNC ID, Scott Number, Plate Number and Description for each issue to be reported. Volunteers will match the dealer's price list to the template and enter the price data. It's hoped that we can have the final product ready for sale in time for STAMP-SHOW in August. Most of the data entry will occur during June and July. Dealers may enter their own data in our template if they choose. One dealer did that last year.

In the April 2004 Coil Line, PNC³ Secretary Tom McFarland, published the member roster which shows the collecting interests of members. In this month's issue, PNC³ Treasurer Andrew Jakes, tabulated these collecting interests. The planned Values List covers the most popular collecting areas, but a few are not included. Data is hard to obtain for some collecting areas.

In this month's Coil Line are the sale results from Auction number 30 prepared by our Auctioneer, Joe Sedivy. Recognizing the interest in prices among our PNC³ members, it would be beneficial if those with a special collecting interest would report on auction results within their

Luminescent ink found on other Scott #3631 To the Editor:

It's time to fire up the old UV lamp, and check your books for another new variety. Scott #3631, the 37c Gummed Flag (from rolls of 100, 3K, and 10K, with 2002 year date) has been found with luminescent ink.

Under longwave ultraviolet, the stripes glow bright orange. Previous examples from rolls of 3K and 10K in my possession do not react. The paper appears the same from the prior printing, and their reaction under shortwave UV is the same. It is my guess that either the red or yellow ink has the luminescent quality, since the reaction of the blue field is the same on both types. The luminescent ink variety is known from rolls of 3K, with pink back numbers.

I do hope most of our membership is keenly aware of the values of items for their collections and not taken in by exhorbitant prices purported to be something they are not-or seem to be!

In a recent issue of Stamp Collector (3-1-04), the classified ads section 3220 "Stamps for Sale, U.S. Coils," an advertiser solicits sale of a SCARCE FLAG over Porch #2915A #89888 fine for \$375. A bit overpriced to say the least. Even Scott's lists that item at \$20.

But the seller may have been grossly misinformed, or confused with a similar number. My PNC3 membership listing shows him a collector of PS5s, so his knowledge should be repleat with prices of such items.

My attempts to confirm by e-mail resulted in no contact with the address given in the ad nor in the previous listed e-address in the latest member list. I finally made telephonic contact. Steve says the number is 89899 which puts it more closely in line with reasonableness.


37c Snowy Egret (AP) (SA) PNC ID 2004-2

This issue of the Snowy Egret by a different printer was available in Kansas City, March 2, 2004.

This is very similar to the first Snowy Egret coil by Avery-Dennison (PNC ID 2003-8). Notable differences are shown in the chart below. Plate numbers are spaced 31 stamps apart yielding three to four plate numbers per roll of 100.

The leader strip shown below binds the roll. Each roll is individually shrink-wrapped.

Sennett 37c Flag Die Cut Gap

In last months Snippets column there was an illustration of a break or gap in the die cutting found on some rolls of the Sennett version of the self-adhesive 37c Flag coils of 100. Two different theories of what caused the gap were presented. Thanks to a source in the Sennett organization, we now know the answer.

The die cut gap has the same cause as the snowman perf holes found on some Sennett water activated gum coils. In both cases, the entire height of the web is not die cut or skived (perfed) at one time, but rather part of the height of the web is die cut or perfed at one station and the remaining part is done at a second station. There is a small overlap and if the second operation is not perfectly aligned with the first, snowman perf holes or a die cut gap is produced.

The source stated that the die cutting process has been changed to one in which the entire height of the web is die cut at one station and thus newer production will not have any gaps. So far only 2222 rolls have been confirmed with the gaps. Either there was no misalignment during the processing of the 1111 production or the 2222 production was processed before the 1111 (this is possible since they were not printed and processed at the same time).

It was speculated that the stamps were printed by J. W. Fergusson & Sons from 10 X 28 subject cylinders and processed by American Packaging. According to the PNC3 web site, they were printed by American Packaging Corp. from 616 subject cylinders and processed by Unique Binders (the usual Sennett team). Since the plate number interval is 14 and it is unlikely there were 44 rows, the plate layout was likely 22 rows x 28 stamps (2 plate numbers per row).

The source could not recall the exact number of rows, but did state that it was more than 10 and not a perfect multiple of 10 (they also indicated the number of rows has changed since production began). At first glance, it

might seem odd that the number of rows is not an even multiple of 10 given the sticks of 10, but they indicated the extra few rolls were just packaged into different boxes than the sticks of 10 were put in.

Dueling Egrets

The recent release of the Ashton Potter version of the 37c Egret coil does not signal the end of the Avery Dennison version of the Egret coil. Avery is still printing them and the two versions will coexist just like the BEP and Sennett versions of the 37c Flag coexist. As the USPS phases out stamp production from the BEP, we can expect to continue to see multiple versions of the same design as they seek to balance out the production capacities of the private printers.


New Coils Due

According to information dug up by Jay Bigalke, three new non-denominated coils will be issued during the second quarter of this year.

(5c) Seacoast	SA 3000	4/6

Details are not yet available on the latter two, but Ron Maifeld has obtained some tentative technical details on the first one.

The self-adhesive Seacoast coils of 3000 are being printed by J. W. Fergusson & Sons for Ashton Potter. This same team produced the self-adhesive Seacoast in coils of 10000, but the technical details indicate the stamps will be different. The images on the new stamps are said to be 0.5 mm wider and taller (not yet confirmed) and the plate number interval is said to have increased to 27 stamps on the rolls of 3000. Dr. Bob Rabinowitz has reported that the back number interval is 10 stamps, which makes the number on number interval 270 stamps.



The Sennett Security Products stamp stick (PNC ID 2003-7) made its first appearance August 8, 2003 at the APS STAMPSHOW in Columbus OH. At the time it was thought that these came in sticks 5 rolls high. It's now known that the sticks are 10 rolls high. They come in a box with no top that holds 5 sticks 10 rolls high. The box is shrink wrapped in cellophane so that the sticks stay in the box until opened.

Post Offices are often surprised when they get these sticks for the first time. When ordering rolls of 100, they can receive either this coil roll or the more common BEP 37c Flag Waving (PNC ID 2002-4) coil of 100 in bubble packs. Though quite different in appearance the USPS considers these the same product. (Both self-adhesive rolls of 100). See the Flag Comparison page in the catalog or from any 37c Flag page at www.pnc3.org.

Three plate numbers are known for stamp sticks i.e., S1111, S2222 and S3333. (PNC ID 2003-7)

As shown on the stick of 10 at the left, one of the S2222 rolls has a black mark on the leader strip. Another unrolled leader strip with a black mark is shown at the bottom of the page. This strip is from an S3333 roll. The S1111 coils did not have these black marks on any of the rolls.

The black marks seem to be some kind of alignment mechanism. Curiously they do not appear at a fixed location in the stack of 10. Sometimes the roll cut is just above or below this mark, but I have seen it cut the mark in half.

I think the leader strips with the stamps attached make a nice collectible. The album pages I use will hold a strip of 12 stamps with the leader strip attached.

Leader Strip From S3333 Showing Black Mark











Shown in the photo to the right are two sticks of 10 with the black mark showing at a different location on each of the sticks. Both of these sticks are plate \$3333.

Plate numbers S2222 and S3333 also have black marks on the trailer strip. The black marks shown in the photo below were under the second to last stamp on the roll. The last stamp on the roll is shown. Note that the black marks here appear on every roll.

I have carefully unrolled some of these sticks of ten saving blocks of 100 (ten high by ten wide). When I save the leader strips, I put cornstarch on the back and front of the leader strip to nullify the sticky residue that remains once the coil is opened. I am told that baby powder might work just as well though I have not tried it. With the stickiness gone, you can safely put the leader strips away in an album.

Plate numbers appear every 14 stamps on this issue. I have saved some leader strips with 15 stamps attached. The plate number can appear on the 1st or 14th stamp on the roll or anywhere in between. It's a real challenge to find rolls with plate numbers in all 14 positions.






S3333 Flag Sticks Black Marks at different spots

Black Marks can also be found near the end of S2222 and S3333 rolls.

A New Slant on Coils?

I recently purchased two rolls of 100 of the Sennett produced 37c Flag S1111 issued 2003. I found the space of the strips' top margins generally decreasing from the end of the roll onward toward the beginning of the roll. Such decreasing margins result in the stripped out PS5s going from an XF at the last position to an F only value at the beginning of the roll behind the leader, Both rolls exhibited the same phenomenon.

Whether the sleeve's images are at an incline in relationship end to end or the web is fed at an angle through the slicing process is undetermined. All stamps are equal in height. The following examples are from the first PN compared to the last on the roll. Salvaged PS5s provide only one creditable collectable strip per roll.



First plate number on roll compared to last.

Seeking condition at the purchase counter throws a curve at the buyer. Exposing and examining the tail-end romances one into the false sense of a well centered roll-only to find the slanting malady on one's own home turf.



Strip of five from center of coil. Note increasing top margin, decreasing on bottom.

Although the top margin differential is not great; approximately 1mm per roll end to end; it none-the-less reduces the desirability of the PS5 strips.

I am unfamiliar if others are finding this circumstance on their purchases of this product or how extensive it might be. One thing for sure, skinny top margins and fat bottom margins don't seem to be my cup of tea!

PNC MAKES MARK

The first in-road to a rare and valuable FOP stamp was recently brought to wide national prominence with the page 1 article in the Vol. 77 No. 3934 issue of *LINN'S STAMP NEWS* (March 22, 2004).


The scarce #66666 plate number of the Flag Over Porch bearing the inverted die-cut of 12/11 was sold by a PNC3 member and dealer while two active bidders battled it out telephonically. The final price of \$3,500 marks the highest price for a used flag single ever and establishes a value in the marketplace for that variety,

As the bids escalated between the potential buyers during the final minutes prior to closing, the dealer listened to simultaneous phone calls. There is now a known level of value established and the PNC community can close one blank door.

The FOP issue has been rife with varieties, EFOs and controversy since its first planned appearance. Scarce and rare varieties have kept the pursuers on their collective toes throughout the active duration of use and great finds are still being made by mixture sorters. But there are still unknown mint copies of this and other varieties. It has made the pursuit an interesting and formidable challenge.

Good luck to hunters and perhaps the known count of two on-cover specimen and 3 U is will increase-but the value is unlikely to go down.

One wonders how many ears may be required in the future?
