

## **Membership Booster Report**

#### Michael J. Conway

Based on face-to-face discussions along with phone conversations I have concluded that 95% of PNC<sup>3</sup> members do not meet face-to-face with other members. As a result, most members do not come together and exchange ideas, learn from other members, swap stamps, make friends, etc.

Over time I have created stamp-hobby chapters in Connecticut. One example is the Irish Philatelic Chapter. For some 14 years this chapter met four times a year in Meriden, CT. (Meriden is located in the center of the state). All members were within 50 minutes of driving. Those four Sundays each year were great times for all. As for PNC<sup>3</sup> members residing in Connecticut, we have also formed a chapter. We hold meetings on selected Sundays.

With the recent Boxborough Show in mind (see "Philatelic Show Report," page 71), we have studied the location of local stamp chapters in MA. Based on American Philatelic Society information, there are 19 local chapters. Given the size of the state, it could require two hours or more for some members to reach a venue. Eight of the 19 chapters are clustered in the greater Boston area. A first estimate of these eight chapters' attendance indicates there are a minimum of 15 PNC collectors (some of whom are PNC3 members and some are not). We have selected a venue for future meetings of the Connecticut PNC<sup>3</sup> collectors, and all of the individual collectors could drive to the venue in 30 minutes or less. There are other potential clusters in MA that we will try to study over time.

Since *Coil Line* reaches PNC<sup>3</sup> members throughout the country, we suggest consideration of applying the cluster idea in your state or a part of a state. ## **Editor's Message**

Welcome to our second issue in the 26<sup>th</sup> year of publishing *Coil Line*. It's the third issue in a row that a page is devoted to the "Current Plate Numbers, Roll Sizes," etc. chart. It occurred to me that if you're not going back to the May issue and marking its chart with the correction noted on page 75, and not marking the April issue's chart with the typos noted in May, an older chart might lead you astray.

This might happen if I grabbed an older issue when looking up something I thought was established (in contrast to "new" PNCs or varieties that are included only after being reported). For instance, days ago I had already completed some math for an article about the 10¢ Clock coil when I received Frank Covey's "catch" of a typo in the May chart about the 2006 version. The math showed the chance of getting a certain cover with two PNCs affixed (one being a 2008 10¢ Clock).

Frank's fix changed a 31 plate # interval to 14, and would almost double the chances that the math determined. As it happened, the cover involved the 2008 date (interval indeed 31) and not the 2006 one.

Speaking of the chart, its overhaul to make it easier to read and update resulted in a few more "bugs." When the proofread file was converted using Adobe software to prepare the publishing files, the last row of specs (Flags of Our Nation sets) got dropped in both the April and May issues. We think we tracked this down to tight tolerances between page paste-up elements, so we made allowances that hopefully avoid the cut-off as of this issue. A similar problem removed the page-number footer on the May back page; this was remedied later for electronic-version subscribers (if you didn't re-download your May copy, you can still do so). — Ron Blanks



While the 1¢ Bobcat coils could have been applied by affixing machine, at least one was not (and likely neither was). One overlaps an edge of the hand-affixed 10¢ Clock; the other is partly overlapped by the hand-affixed PNC.

The round Tuit wasn't very large, but I finally got one so I can now ask: What do we know about signs on a Sennett-made coil stamp to show the coil came from the top row of the printed web? Theoretically, an extra-tall stamp or web misslitting of the rows might capture a register mark or other print-ink evidence above the stamp design.

But I was thinking of something more mundane that might be seen in misaligned diecutting of a normal-size stamp. Below are three examples of "cobras" on Sennett  $37 \, \phi$  Flags (Scott 3632C) I accumulated years ago. The example in the middle doesn't quite look like the other two. A closer look shows that the die cutting "stops" so the paper is actually torn at both corners. Would this be a hint that the stamp came from the top row, or is there another possible reason?  $-Ron \, Blanks \, \#2119$

#### New USA Philatelic: Hit or Miss Surprises

No reprint of the 3¢ Coffeepot is listed in the new 2013 Quarter 2 issue of *USA Philatelic* even though we know it exists (with plate # S2222; one is illustrated elsewhere in this *Coil Line*).

#### 10¢ Clock Reprinted with New PNC

A "2/2013" reprint of the 10¢ Clock is also The specs given (offset printing, plate # interval every 31 stamps) are the same as the 2008 printing (Scott 3763), which is no longer listed in USA Philatelic, although the original 2006 version (Scott 3762) is still offered. No indication is given as to whether it is phosphor-tagged or not. Presumably the reprint they are offering is the S2222 printing, which PNC<sup>3</sup> officer-at-large Michael Mules has confirmed on a Disabled American Veterans cover. Back numbers are not expected as it has recently been reported that water-activated gum (WAG) coil stamps will no longer carry back numbers. They started omitting the back numbers on WAG coils when a shortage of food-grade ink developed. It was supposed to be a temporary allowance, but apparently they decided to make it permanent.

#### 5¢ Toleware Reprinted without Backnumbers

The surprise in this *USA Philatelic* is a 5¢ Toleware "12/2012" reprint is also listed. The given specs are identical to the original 2002 printing, and Richard Beecher reported in the online BidStart/Virtual Stamp Club forum that the strip of 25 he received from the Caves with a "REP AMERICAN TOLEWARE" sticker showed no differences from the original besides the lack of back numbers.

#### Full Rolls Only of WAG Coils?

The other interesting thing is that all the WAG coils are only listed as being available in full rolls. While this would be a new problem for collectors expecting to obtain a PNC in the strips of 25 that

used to be offered, Richard was obviously able to order a strip of 25 for the 5¢ Toleware reprint. However, he was not able to order a strip of 25 of the 10¢ Clock, so clearly it is a confusing situation as this is written in early May.

#### New "Strip of 10" Option Online

At the opposite end of the spectrum, the May 10 *Linn's Stamp News* reports the 46¢ Star and 46¢ Kaleidoscope Flowers are not only available in strips of 25 (with plate #), but also in strips of ten (without plate #) through the online USPS Postal Store, although this option is not listed in *USA Philatelic*.

#### PNCs on Different Flags for 2013 Editions!

The plate # interval for the Avery version of the new 2013 Flag for all Seasons coils of 100 is erroneously listed in *USA Philatelic* as every 21 stamps, which isn't possible (it has to be a multiple of four since there are four designs). Reports from collectors with stamps onhand are in and stamp supplier Sennett has thrown us a curveball. The plate number on the Aston Potter and Avery coil versions is on the "Spring" stamp, but Sennett put it on the "Summer" stamp. This is the first time something like this has happened (among multi-design issues), and it will be interesting to see if this gets corrected if Sennett does a reprinting.

## **Safe Soaking**

I tried the "Safe Soaking" process with warm water and Softsoap to remove self adhesive stamps from paper, as initially suggested in the March 2013 issue of the *American Philatelist*. I gathered about 50 different U.S. stamps issued during 2012 for my experiment, including coils, stamps from booklets, and commemoratives.

None of the stamps floated off the paper, as one experiences with water activated stamps. I soaked the second batch of about 25 stamps for six minutes rather than the suggested four minutes, with no apparent difference in end result. I found that current U.S. self-adhesive stamps need coaxing to be removed from paper. Almost one-half of the stamps had no self-adhesive material remaining after using the warm water-Softsoap mixture. I reverted to the lighter fluid soaking process to remove the self-adhesive from the other stamps. The items produced by Sennett Security Products more readily lost the self-adhesive bonding. Yes, a few stamps could not be removed successfully from the envelope paper and were discarded.

I am disappointed that the "Safe Soaking" process was not totally successful, but probably will continue to use it. It reduces the need to rely entirely on the lighter fluid separation approach.

## 3¢ Coffeepot S2222 in PNC Combo

Ordinarily, finding a new PNC like the S2222 of 3¢ Coffeepot on-cover with another PNC would not be news. Alert readers will recall the S2222 was first reported earlier this year on a Disabled American Veterans reply cover. When the DAV franks some of its courtesy reply envelopes with "live stamps," it typically uses two different denominations of coils. (*Coil Line* happens to show elsewhere in this issue some of these covers.) Based on probabilities given later, both coil strips might contain PNCs.

The cover shown nearby is an outcome of this chance. But unlike the typical reply cover, this one is found in interesting circumstances: It is encased in a cellophane mailer partially obscured by other contents.




This technique is employed at times by some direct-mail marketers as yet another variation in

creativity. Their aim is to pique the recipient's interest so the mailpiece is opened rather than discarded. Cleverly, the insert over the reply cover is at a reduced size so that in most cases of content-shifting, odds are some of the colorful stamps remain visible.

Because the location of any plate number is at the bottom of coils, usually any PNC is not visible through the unopened cellophane at first (except in extreme cases of shifting with a right-most PNC location). I've collected several of these types of mailings in recent years from a handful of organizations. I refrained from opening the package and tried to shift the contents to reveal any PNCs.

In this case, the coils' position and the various dimensions involved easily revealed the  $3\phi$  PNC near one corner. The  $10\phi$  strip was a more typical challenge. Careful tapping moved the insert to the edge at one side and the cover to the other side. Fortuitously, one of the  $10\phi$  Clocks is also a PNC. (See the closeup image below.) But more handling will move the contents again, hiding the S1111.

The odds of having a PNC in each strip are chances of a number on any of the 10¢ coils (4 of 31, or 13% of any strip of 4) times chances on one of the 3¢-ers (2 of 14, or 14.3% of any pair). The likelihood that any of this mailing has two PNCs is just under 2% (1.859), or almost one in every 50. This discussion portends an article I have long planned but not "gotten-to," calculating the odds of PNCs on each American Design coil strip used on various DAV reply covers! It would be interesting to know which PNC combos, if any, have significantly lower odds.

But my intent here, besides showing an interesting combo PNC cover, is to point out that the "hidden" 10¢ PNC (please see page 80)

## 5¢ Toleware Rolls Constantly Used Regardless of Rates

Once it became known that the USPS was offering reprint rolls of Sennett Security Products'  $5\phi$  Toleware (e.g., *USA Philatelic* 2013 Quarter 2, page 38), collectors speculated online why more rolls of 10,000 were needed. The main discussion centered around the first-class rate change from  $45\phi$  to  $46\phi$  this past January and its impact on Disabled American Veterans' use of stamps on its courtesy reply envelopes.

Like the report in last month's *Coil Line*, the 46¢ version of DAV reply covers are showing up with strips of three 10¢ Clock and strips of four 4¢ Chippendale Chair coils. (A similar cover I received in May is shown below). Some speculated that the DAV's use of 5¢ coils during the 45¢ rate depleted USPS inventory sufficiently to require more rolls, regardless if the present rate is not a multiple of five.



Other speculation proposed the DAV would affix ten stamps to courtesy envelopes, six  $5\phi$  and four  $4\phi$ . But a cause of continuous consumption of  $5\phi$  rolls irrespective of first-class rates was mostly overlooked.

Five cents (of the U.S. dollar) happens to be the common factor of values assigned to all presort undenominated coils provided by the USPS since 1995. The presort coils are tied to a streamlined policy effective that year and continuing ever since. The policy supports mass mailers' use of live postage on bulk mailings in the face of a myriad web of discounted rates.

Thus, we were introduced to more PNCs in the

form of non-profit organization-rate coils (priced  $5\phi$  each, for mailers qualifying for special rates in the bulk third class, later called standard, class). A nonprofit mailing with one of these coils affixed to each mailpiece is counted as having  $5\phi$  per piece postage paid so far. When the mailing is accepted, the mailer's account is charged the difference between this amount and total postage due, based on the eligible work-done discounts earned (sorting, automation barcoding, etc.).









Likewise, commercial standard-class mail can use the "presort standard" coils, priced a nominal 10¢ each; first-class postcards used presort coils that cost 15¢; first-class mail have coils that cost 25¢. The USPS set these "minimum" values back in 1995 to be below the lowest discounted rates possible in the respective mail classes.

Besides the system simplifying accounting greatly, the low values accomplished two things: They allowed the mailers to tie up less funds invested in coil rolls between mailings, and of course they almost eliminated the need for refunds when a mailing's postage cost totaled less than the postage value affixed.

When the USPS standardized the set of presort coils for mailers to choose from (based on the class of mail used), (please see page 80)

places this cover in an interesting category: PNCs in the mailstream but hidden from sight. I believe our previous highlighted entry in this category was a 23¢ Washington #V46 on a first-class parcel, covered by a large red "SCAN" sticker (July 2010 *Coil Line*). I have at least one more type of cover in this category to share in the future; do you have any of a similar kind? We should try to feature these a little more than once every three years!

## Will 5¢ Toleware reprint rolls (no backnumbers) show differences from earlier rolls?

This is not likely, seeing the range of "normal" variability found in older rolls. This random sample of three PNCs shared by John Himes shows how the color shades can differ slightly, given the high number of inks involved as shown in the plate #s:

the minimum postage values to be applied uniformly to each mailpiece was also set for cases where the mailer applies postage without using an undenominated presort coil. This point is overlooked by most collectors; I've seen some interesting discussions as debate arises about creative mailing uses. Various parts of the Domestic Mail Manual will get quoted as discussion misses this simple implication of the various regulations:

The USPS allows creative leeway on use of stamps as long as these nods to the accounting work at mail acceptance are made: (1) Each mailpiece must be uniformly franked, (2) the franking must be a minimum value for the respective class (see presort coil values, above), and (3) of course for non-presort (or non-precanceled, the traditional term) stamps, the mailer must precancel them by acceptable means under a Mailer's Postmark Permit (MPP).

Now we might recall seeing an example of that most-oft use of  $5\phi$  Toleware rolls (first released in 2002) year-in and year-out, irrespective of the rates: Pairs are sometimes used as attractive alternative to the presort-standard rate ( $10\phi$ ) coil (current design, the "Patriotic Banner"). These seem especially popular for political mailings, as examples depicted at left and on the front cover show.

Interestingly, you might wonder why nonprofit mailers don't use the  $5\phi$  Toleware more often as a substitute for the current  $(5\phi)$  presort coil [Art-Deco Bird], since presort coils can become "old hat" soon after their introduction. (The USPS stated way back in 1995 it was their plan to introduce new presort coil designs about every three years, but that lofty goal quickly fell by the wayside once the 1990s passed.)

Instead of single 5¢ Toleware stamps with MPP cancels, we usually see combos that add up to 5¢. I imagine that once a mailer arrives at a decision to "do something different" to get their mail opened by leaving the presort-coil path, they like to combine a second design since they're using the overhead of water-activated coil affixers as well as applying an MPP cancel. (In any event, note that most mailers out-source the work to lettershops well-practiced in franking creativity. I got a kick recently by recognizing the same third-party firm had prepared both a nonprofit mailing and a political mailing. I will try to include examples in a future issue.)
